Definitions

Definitions and requirements in the legislation regarding the prevention and detection of money laundering and financing of terrorism.

Please note that the definitions and requirements may vary depending on the jurisdiction.

Beneficial Owner (BO)

The beneficial owner is a natural person who owns or controls the legal entity by:

- holding more than 25% of the shares directly
- holding more than 25% of the shares indirectly through another legal entity / entities
- controlling the legal entity through an agreement, company agreement, article of association or equivalent
- having the right to appoint or dismiss more than half of the board / executives of the legal entity

In case none of the above can be identified, the chairman of the company, CEO or equivalent shall be considered to be a beneficial owner of the legal entity. In a foundation or a trust a founder, trustee, beneficiary or a board member shall be considered to be a beneficial owner.

Politically Exposed Person (PEP)

Politically exposed person refers to a person who has or, the latest 18 months, has had an important public or political role. A person, whose family member or close associate has or have had a public or political role, is considered to be PEP.

The following roles are considered to be important public or political roles:

- Head of state or head of government
- Minister
- Deputy / assistant minister
- Member of parliament
- Supreme court judge
- Judge in other courts or judicial bodies that constitute a final court of appeal
- Senior officer of a national governmental auditing authority
- Board member of a national central bank
- Ambassador
- Chargé d'affairs
- Senior officer in the armed forces
- Member of the administrative or supervisory body of a state-owned enterprise
- Director, deputy director or board member of an international organization
- Member of the governing body of a political party elected in the national or EU parliament

In case the BO is a PEP, related to one or is a close associate of a PEP, the role and the relation must be stated in the form.

The relations can be the following:

- The beneficial owner is a PEP
- Spouse
- Registered partner
- Co habitant
- Child
- Child's spouse / reg. partner / partner
- Parent
- Close associate of a PEP; for example a person who owns or controls a company together with a PEP or a person who owns or controls a company which is founded with a scope to benefit a PEP or equivalent relation to a PEP

The requirement to investigate the beneficial owner, for us as operators, covers all forms of organization, including government agencies.

Instructions

Please note that all relevant sections need to be filled in.

Step 1: Fill in the company information.

Step 2: State the ownership structure in the section 2. Please note that by pressing the + you can add a section for new entities.

In case the ownership structure is complicated you may always attach an organization chart. Please include the percentage of the ownership in the chart.

Step 3: Please state the information regarding the BO and the type of BO.

Step 4: In case not any natural person can be identified as a PEP, one or several of the following persons must be stated as a BO: chairman of the company, board members of a company, CEO or equivalent. Please note that the requirement may vary in different jurisdictions.

Step 5: The BO's possible relation to PEP must be stated for each BO.

Step 6: The form must be dated and signed by authorized signatory / signatories.
